From Venice Marco Polo Airport: Public transportation

Transfer by public land bus to Piazzale Roma plus public boat bus (vaporetto).

Land bus n° 5 or direct line from the airport to Piazzale Roma.

From Piazzale Roma: Public boat buses (vaporetto) n° 41 or 2 direction Giudecca.

Cost approximately €10 per person.

The closest water bus stop to the Hilton is Palanca.

Excursion by boat to Murano, Burano, Torcello including guide, entrance fee to the glass factory & church of Torcello and 3 course lunch.

Our local guide will accompany you on a motorboat trip to the most famous islands of the lagoon. On the way you will see the islands of San Giorgio, Lido and the island of San Francesco del Deserto which houses a monastery where St. Francis is believed to have stayed. First you will reach the fishing village of Burano, where each house is painted in a different colour and famous for its lacemaking which you will be able to see. Then you will visit the beautiful island of Torcello which was the first island inhabited by the Veneto people fleeing from the barbarian invasion. On the island stands the Cathedral (rebuilt in the 11th century), with its magnificent Byzantine mosaics, and the Church of Santa Fosca (about 1000AD). Lunch will be served in Torcello. Last stop is at the island of Murano, once famous for its beautiful villas and gardens and now the centre of the world famous Venetian glass industry. You will have a chance to visit a glass-blowing factory before returning to Venice.

The heart of Venice:
Classical Venice with Gondola Ride

The tour includes a guided visit to Piazza San Marco, which is considered the heart and soul of Venice. It is a regal square bordered on three side by arcades, on the south by the great Basilica of St. Mark's, one of the world's most magnificent churches. The Piazza San Marco is the Venetians open-air drawing-room. Here all the major events of the city's long history were played out, here the Republic was born, flourished and died. Next to the basilica you can admire the "Palazzo Ducale" also known as the Doge's Palace. It was given this name as early as the 9th century when the first supreme head of the Venetian state took up residence there. It is a Byzantine structure erected over pre-existing roman walls. The original building was destroyed by fire and had to be rebuilt several times. It was not until 1340 that it took on its present appearance as a Venetian Gothic place. Imposing and majestic, the palace is at the same time the epitome of grace and elegance. Last stop at the Bridge of Sighs, perhaps the most celebrated bridge in Venice together with the Rialto bridge. This structure passes over the Rio di Palazzo connecting the Doge's Palace to the prisons. Prisoners would cross it on their way to appear before the judges and look through the lattice work windows, and be heard to utter sighs of sadness for their lost freedom. A gondola ride on the Grand Canal as well as smaller side canals is included.
