Lawyer's 'Acknowledgement of Debt' With Former Romantic Partner Is Unenforceable

Before the parties lived together from 2007 to 2019, defendant was married to nonparty Kaczmarek. Defendant and Kaczmarek litigated a divorce action between 2002 and 2006, when their divorce was finalized. Plaintiff lawyer alleged that, during the divorce action, he provided advice to defendant, appeared on her behalf in the proceeding, assisted in negotiating a settlement, and helped obtain a favorable resolution. Plaintiff also helped defendant deal with the acquisition and development of a property that was an asset in the divorce action. Defendant did not pay plaintiff for his legal services, but she later signed a document titled "Acknowledgment of Debt" that acknowledged a debt she owed plaintiff for legal advice and services he previously provided for the potential future sale of the property. After the parties' romantic relationship ended in 2019, plaintiff sued for breach of contract to enforce the Acknowledgment of Debt. The court dismissed the action, finding the Acknowledgment of Debt an unenforceable contract under GOL §5-1105, noting plaintiff did not abide by rules governing attorneys' representation of clients in matrimonial actions.

Pre-Deposition Surveillance Video Is Precluded; Post-Deposition Videos Are Not Precluded

Pizzo claimed injury in a 2017 crash with a vehicle driven by Lustig. On Feb. 7, 2019, Lustig's insurer AIG retained ISG Litigation Solutions to conduct surveillance of Pizzo. From that date to Dec. 16, 2020, Lustig acquired eight sets of video surveillance footage: the first obtained before Pizzo's deposition on March 4, 2020, the others thereafter. After seeking summary judgment under Insurance Law §§5102 and 5104(a) Pizzo moved, under CPLR 3101(i) and 3126, to preclude Lustig's use of the videos. Supreme court held Lustig's late disclosure of the surveillance material was not shown to be willful, contumacious, or prejudicial, and denied Pizzo preclusion. Modifying judgment, Second Department granted Pizzo preclusion of surveillance materials taken by Lustig in mid-February 2019 pursuant to the New York Court of Appeals' 2003 decision in *Tai Tran v. New Rochelle Hospital Med. Ctr.* It otherwise affirmed the denial of preclusion as to all post-deposition surveillance-related disclosures. Nothing in CPLR 3101(i) bars the acquisition of a surveillance video of a party after that party has testified at a deposition.

Pizzo v. Lustig, 2022-00146 (May 10)

NYS Establishes Identity of Issues Between Court of Claims Case and the Instant Action

Plaintiff New York State sued to recover \$12.5 million in funds advanced to defendant Please Me LLC for the purchase of 1,000 ventilators with compressors in the early days of the COVID-19 outbreak, together with a 22% collection fee pursuant to State Finance Law §18 and pre-award interest. Plaintiff now moved for summary judgment, based primarily on a decision of the court of claims dismissing defendant's claim for breach of contract against plaintiff on the ground that defendant breached the contract by failing to timely deliver the ventilators. The instant court granted plaintiff's motion and awarded it judgment against defendant in the amount of \$12.5 million with interest, representing the funds advanced to defendant under the contract, plus a 22% collection fee, in the total amount of \$2.75 million. The court concluded that plaintiff established an identity of issues between the court of claims case and the instant action and therefore demonstrated its entitlement to summary judgment as to defendant's liability for breach of contract through the application of the doctrine of collateral estoppel.

Insurer Need Not Defend, Indemnify Law Firm In Suit Over Theft Of Client Funds at Closing

Law firm Huang & Associates represented the buyer in a real estate transaction. Unknown persons accessed an email chain relating to disbursement of funds and stole over \$500,000 of the clients funds. Sued in state court for legal malpractice and negligence, Huang's insurer Hanover denied coverage under the law firm's professional liability policy. Informed by the New York Court of Appeals' 1996 decision in *Mount Vernon Fire Ins. Co. v. Creative Housing Ltd.* district court granted Hanover dismissal of Huang's action to compel its defense or indemnification of Huang in the state court action. The policy excluded claims "arising out of" or "relating to" any attempt to convert or to misappropriate monies or property. Reading *Mount Vernon* and the Appellate Division, Second Department's ruling in *Watkins Glen Cent. Sch. Dist. v. Nat'l Union Fire Ins. Co. of Pittsburgh PA* together, district court was persuaded that New York's high court would apply the rule in *Mount Vernon* to Huang's malpractice policy. Instantly, the language of Huang's policy favors insurer Hanover.

NEW YORK | FAMILY LAW

Mother's Quest to Relocate Son to Pennsylvania Is Not In the Child's Best Interests

Following a 2018 judgment of divorce, defendant mother sought permission to relocate with the parties' nine-year-old son, J.H., to Pennsylvania, approximately 125 miles away. The court held a trial and denied defendant's motion, finding defendant manipulated various people, including a teacher and a neuropsychologist, in her quest to support her relocation. The court also determined that defendant purposely did not include plaintiff father in aspects of the relocation and school application process, including by providing a false email for plaintiff, and violated court orders, all of which seriously undercut defendant's trustworthiness and showed that she placed her desires and interests ahead of her child's interests. The court added that the way in which the parties navigated exchanges during the pandemic and during the instant litigation once defendant purchased her home in Pennsylvania cannot now be used to establish some factor in favor of the relocation. Finally, the court stated that J.H. has only known New York as his home, attends occupational therapy in New York, and has monthly meetings with a psychiatrist in New York with whom he has a good relationship.

Plaintiff Granted Extension of Time to Complete Personal Service, Remedy Deficiencies

Plaintiff brought an action under the Child Victims Act, alleging that as a minor attending school at defendant Yeshiva of Brooklyn, he was subject to repeated sexual abuse by defendant Rabbi Nussbaum, and that the Yeshiva and its principal, Rabbi Mandel, knew of the abuse but allowed it to continue. The Yeshiva and Rabbi Mandel sought vacatur of default judgments granted to plaintiff, arguing plaintiff's process server did not leave the summons and complaint with an employee but instead left them on the front door after standing outside for a minute and not interacting with anyone. Plaintiff maintained service was proper but, should the court find otherwise, cross-moved for an extension of time to complete service. The court vacated its prior default orders against defendants and granted plaintiff's cross-motion for an extension of time to complete personal service upon them, finding that plaintiff demonstrated that the interest of justice warrants an extension of time to remedy any deficiencies in his earlier, timely attempt at service. The court added that dismissal of the action would severely prejudice plaintiff, given that he would not be able to bring a new action.

Conspiracy Lawsuit's Dismissal as Violative Of Prior Anti-Filing Injunction Is Explained

In 2014 New Jersey's Board of Medical Examiners revoked Kaul's medical license. Kaul filed lawsuits alleging that lawyers, hospitals, insurers, and others conspired to make public officials bar him from practicing medicine in New Jersey. Several actions were transferred to the District of New Jersey, which dismissed suit. In a 2021 lawsuit Kaul alleged six conspiracies, including "a Slaving-Nazi-COVID-Insurance Axis." District court's Sept. 12, 2022, dismissal barred Kaul from filing "new actions arising from [those] facts." Kaul's instant unpermitted action alleged a Sarbanes-Oxley and RICO violations and that the defendant insurers are committing racketeering through a Slaving-Nazi-COVID-Insurance Axis to "force mass global vaccination programs." The court dismissed suit under FRCP 8(a)(2) and for violating the prior 2022 anti-filing injunction. Kaul's instant action arose from the denial of his medical license, as did his nearly identical previous allegations. Most of Kaul's claims were also collaterally estopped by the Sept. 12, 2022, order dismissing Kaul's 2021 complaint.

AT&T Adequately Alleged Joint Employer Of Transgender Woman Claiming Bias Under Title VII

Premier Technologies is an official retailer for defendant AT&T Corp. Hired as a sales representative with Premier plaintiff transgender woman Weiss was supervised by Sturdy. Weiss complained to Premier human resources associate Weiler about adverse employment actions by Sturdy, which continued after both were transferred to another Premier store location. Weiss's employment was subsequently terminated. On Feb. 24, 2021 the EEOC issued a right-to-sue letter in connection with Weiss's Sept. 16, 2020, discrimination charge. Sued with Premier for discrimination and retaliation violating Title VII of the Civil Rights Act and New York's Human Rights Law, AT&T sought dismissal arguing that Weiss failed to state a claim because she did not show that AT&T was her employer. The court denied AT&T's dismissal motion. Weiss's amended complaint sufficiently averred employee discipline, supervision, and control by AT&T to plausibly allege that AT&T was her joint employer. The court viewed AT&T's arguments to the contrary a premature attempt dispute the amended complaint's factual allegations.

BRONX | DISCOVERY

People Demonstrated Due Diligence In Disclosing Discoverable Items After COC Filing

Defendant moved for dismissal of misdemeanor charges brought against him on statutory speedy trial grounds, contesting the validity of the People's certificate of compliance (COC) and supplemental COC (SCOC) due to the People's failure to comply with disclosure obligations before the expiration of the speedy trial time. Defendant asserted certain items were belatedly produced after the People filed their COC, including a video taken from a witness during the incident, and domestic incident and complaint reports filed by complainant. The People alleged the COC and SCOC were valid because they have already disclosed the requested information, some of which only became known to them after continuing to investigate the case and after the filing of their initial COC; and because the information was not within their custody and control. The court denied defendant's motion, holding that the People demonstrated, in detail, their due diligence and good faith efforts to disclose discoverable materials after filing their COC. Among other things, the court found that the People persuasively argued that the requested video was not shared with them until after they filed their COC.

RICHMOND | EDUCATION LAW

Decision to Deny Teacher Accommodation For Vaccine Mandate Was Arbitrary, Capricious

Petitioner, a teacher with respondent NYC Department of Education (DOE), had submitted a request for a medical exemption to the COVID-19 vaccine mandate based on various medical conditions that prohibited her from receiving the available vaccinations against the virus. Petitioner now alleged that the denial of her request for a medical exemption was arbitrary and capricious. The court granted the petition and held that petitioner was entitled to a medical exemption from the vaccine mandate, concluding that the DOE's decision to deny petitioner a reasonable accommodation to the vaccine mandate based on her medical conditions was arbitrary and capricious. In finding that the DOE's actions were arbitrary and capricious, the court noted that petitioner was granted a medical exemption from the fall of 2019 through Jan. 2023 and, upon being asked to re-apply for a new reasonable accommodation by the DOE, her request was denied as not medically warranted and that her conditions did not qualify for an exemption under the CDC guidelines. Further, the court noted, the DOE shortly thereafter extended petitioner's initial medical exemption against into Feb. 2023.

Defamation, Abuse of Process Claims Stand In Condo Super's Rights Suit After Firing

In January 2020 Lazar was fired as a superintendent for the Aurora Condominium, and instructed to vacate his apartment by the end of February. Police arrested him on Feb. 28, 2020, after defendant Jewels, a member of the Condominium's managing board, accused him of unlawfully removing items from the building. The Condominium and Jewels (Aurora Defendants) published a March 2020 newsletter falsely claiming that Lazar was a thief. All charges against Lazar were dismissed in 2021. His Third Amended Complaint alleging false arrest and malicious prosecution also accused the Aurora Defendants of defamation and abuse of process. The court denied those claims' dismissal. The court could not decline to exercise supplemental jurisdiction over such claims. Further, the TAC alleged facts sufficient to show "malice," overcoming the "common interest privilege" that negates a defamation claim. The TAC alleged the Aurora Defendants misled the police by falsely stating that Lazar was stealing from the Condominium when they knew or were reckless in not knowing that he was clearing out his personal belongings from his assigned storage unit.
